Metal Coolant Merchants (N6314): Metal has been out of business or moved (about 2004). MDEQ-RRD may conduct follow up investigation regarding this facility because Metal or MCM melted lead (Pb) and recycled lead and antifreeze.

On June 19, 2018, I conducted a level 2 self-initiated **FY 2018 inspection** of Axis Metrology, Inc. ("Axis"), metrology machines trading and repair facility, located at 48861 West Road, Wixom, Michigan 48393-3554. The inspection was conducted to determine compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451 and Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) administrative rules.

Metal Coolant Merchants (N6314) has gone out of business or moved out. Currently (2018), at Axis Metrology, no Clean Air Act regulated activities (2018). MDEQ-RRD may follow up on lead (Pb) and antifreeze (Ethylene Glycol) concerns.
