VIOLATION NOTICE

On September 13, 2024, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), received the July 15-16, 2024 Covert EU-TURBINE1/EU-DB1 (Unit 1) and EU-TURBINE3/EU-DB3 (Unit 3) stack test results of Covert Generating Station located at 26000 77th Street, Covert, Michigan. Based on a review of this report, AQD staff noted the following violations:

On July 15-16, 2024, stack tests were conducted which indicated that emissions from the company's Unit 1 and Unit 3 exceeded the allowable emission rate specified in Special Conditions I. 11, 12, and 14 of MI-ROP-N6767-2020a).

The allowed maximum emission rate of PM_{10} and $PM_{2.5}$ is 10.7 pounds of particulate matter per hour. However, actual emissions were recorded to 18.1 and 11.3 pounds of PM_{10} and $PM_{2.5}$ per hour of exhaust gas for Units 1 and 3 respectively.

Covert Generating Station has included a preliminary explanation concerning the July 15-16, 2024 stack test results in their August 28, 2024 response to the August 7, 2024 Violation Notice from the Air Quality Division. The facility has also indicated that their additional testing has provided more reliable results, which showed the units to be

operating within permit requirements. A response to this violation notice is not required, however, if Covert Generating Station wishes to provide a response to this violation notice, please submit a written response to this Violation Notice by October 14, 2024 (which coincides with 21 calendar days from the date of this letter). We look forward to receiving the additional, new test result report(s) by the required deadline(s).
