In response to your letter dated 10-1-19 regarding the Violation Notice for our Kalamazoo plant citing alleged deficiencies noted during an inspection don on July 30<sup>th</sup>, Rieth-Riley does not anticipate making any changes to our maintenance or inspection procedures or recordkeeping at this time. All of the information requested has been kept as required and was available. There may well be some issues related to the staff on site understanding exactly what was being requested, and what was easily at hand on site. These should be easily addressed. The attached record clearly documents Spring maintenance activities undertaken in early 2019, though the dates do not exactly match the dictates of the permit. Timing of these activities is driven by contracted workload and weather and are unlikely to be entirely completed between 12/1 and 4/1 in any given year. Additionally, there are a number of items highlighted in the information you sent to me to further document that do not exist as part of this plant, and therefore are not being addressed in any way in our records.

Rieth-Riley expends considerable time and effort in training and monitoring to ensure compliance with all environmental rules. Thorough investigation of the information available here leads us to the conclusion that we were in violation of the Permit Condition for EUHMAPLANT cited here.
