### FACILITY BACKGROUND

A & E Aggregate operated a portable concrete crusher. The crusher was last located at 29001 Michigan Avenue in Inkster Michigan.

### COMPLAINT/COMPLIANCE HISTORY

No complainants have been received regarding this facility. No Violation Notices (VN) have been issued to this facility.

### PROCESS EQUIPMENT AND CONTROLS

The facility had operated multiple portable crushing units, with each unit permitted under a separate SRN. The permit associated with this current SRN was voided on April 29, 2008.

### INSPECTION NARRATIVE

On Friday October 9, 2015 I arrived in the last known location of this portable crusher, which was at 29001 Michigan Avenue which is near the intersection of Michigan Avenue and Middlebelt Road in Inkster, Michigan. This location is no longer past of Doan Concrete, and the concrete silo has been removed. The entire area is now surrounded by a fence, and I believe is part of H & H Metals, which is a metal scrapping facility on the adjacent property.

On October 13, 2015 I called the MACES contact for this facility, Mr. William Fyke. Mr. Fyke was unavailable, but I spoke with an employee named Barb. Barb said that the facility operates one portable crusher. She said that the facility has not operates a crusher at the Michigan Avenue in Inkster in many months. She said that the crusher is currently located at 327 Brown Road, Orion Township, Michigan. According to MAERS, the crusher that A & E Aggregates is currently operating is N3396. The crusher assigned to N7444 is no longer operated by A & E Aggregates.

### APPLICABLE RULES/PERMIT CONDITIONS

The crusher assigned to this SRN was issued a general metallic portable crusher permit, number 70-00. This permit was voided on April 29, 2008.
