VIOLATION NOTICE

On January 14, 2015, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Martin Technologies located at 55390 Lyon Industrial Drive, New Hudson, Michigan. The purpose of this inspection was to determine Martin Technologies's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules and the conditions of Permit to Install (PTI) number 352-05.

During the inspection, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
Dynamometer engine testing	Special Condition number 1.1b, 1.2, and 1.3	Records of CO emissions and gasoline usage for engine dynamometer test cells were not submitted. Emissions and usage records must be based on a 12-month rolling time period.
	Special Condition number 1.4	All required calculations for the previous calendar month shall be completed in a format acceptable to the District Supervisor by the 15 th day of each calendar month.

During this inspection, Martin Technologies was unable to produce emission records. A message was left with the company on January 26, 2015. An email was sent February 9th asking for records to be submitted by Friday, February 13th, 2015. As of the date of this letter, the AQD has not received the requested records.

This is a violation of the recordkeeping requirements specified in Special Conditions 1.1b, 1.2, and 1.3 of PTI number 352-05 which is enclosed.

Special Conditions 1.4, 1.5, and 1.6 require those emissions records and usage records be completed by the 15th day of each calendar month and be made available for review upon request of the AQD staff.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by March 20, 2015 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Martin Technologies believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.

Thank you for your attention to resolving the violations cited above and for the cooperation that was extended to me during my inspection of Martin Technologies.
