This report is for a scheduled compliance inspection for General Permit to Install (GPTI) 283-07 for a soil or groundwater remediation system. The system was located at the Atlantic Richfield Company Remediation site in Napoleon.

Facility Address: 102 West Brooklyn Rd. Napoleon, MI

GPTI 283-07 was for a remediation system that consisted of soil vapor extraction (SVE). The Atlantic Richfield Company remediation site was former Amoco Service Station 7185, and the system was designed to clean up gasoline contamination. There was no evidence of any activity in the Jackson District files that the system had ever been inspected.

I contacted RRD staff in the Jackson District and found that the site had been documented as not operating. Since AQD had minimal facility contact information, RRD staff were able to provide contact information for the site. See attached email correspondence.

I contacted Holly Fett, the facility contact information obtained from RRD, and she confirmed that the remediation system has not been operating since April 2016. She also gave an update as to what has been happening at the site since 2016, concluding with the removal of all equipment.

I informed Holly of the procedure for requesting that their permit with AQD be voided, and I thanked her for her cooperation.

Summary:

Based upon the information outlined above, this site is no longer operating. It will be marked as permanently closed in MACES once the PTI is officially voided.
