Inspection Summary

I stopped to inspect this site on 10/7/16. The site is an active Marathon gas station. There is a remediation device within a shed located on the east side of the lot nearest the neighboring Burger King. I took a picture of the shed (attached) with contact information. There is an electric meter in the shed that appears to be disconnected and no noise was coming from the shed. I spoke with the manager, Stacey Hendrickson, who stated she did not have access but said the consulting firm performs well checks on a quarterly basis.

On 10/21/16, I emailed Jeff requesting documentation of compliance in accordance with the permit after receiving his information from Jim Innes. On 10/24/16, I called and left Jeff a voicemail.

In the afternoon of 10/24, I received a call from Paul Bojtsen of Stantec. Paul informed me that the device has not run since 2012 and they did not foresee further reason to run the device. Since the device is still installed and is capable of operating, I informed Paul that the permit would remain in effect. I did not request records due to the length of time since last operating. I did request that Paul inform us when the device was removed from the site so we could then void the permit.

Although the site is not actively running the remediation device, the AQD database MACES will continue to have the site registered as active until the permit is voided and the device removed.




Image 2(Device Shed) : Device Shed
