On July 22, 2014, AQD District Staff attempted to conduct a scheduled site inspection for the Huron Forest Crematory, 4721 Industrial Row, Au Sable Township Industrial Park, Oscoda, Iosco County, Michigan. Upon arrival staff noted that there was no sign at the road, and that there was no sign of occupancy in the building. No posted contact information or office hours.

District Staff left a business card in the door requesting a call. The status of the facility is being changed to temporary closure until it can be confirmed that the facility is operational. A google search of crematories in Michigan failed to identify the business. A property and land search thru the Iosco County website identified personal property for the address owned by Huron Forest Crematory, Inc. (Wane D. Bigelow, PO Box 592, East Tawas MI 48730), and the land owned by Nan Regina Properties LLC (Nan R Buresh, 2100 Au Sable Point Rd, East Tawas, MI 48730). Letters requesting a call will be sent to both parties. sgl


