### FACILITY BACKGROUND

Next Tool is located in Belleville, Michigan in an industrial area south of Ecorse Road and east of Haggerty Road. The facility is a tool and die shop. The facility operates one shift per day, five days per week.

This address is permitted for Treatmed Inc, which was a medical sterilizer. Treatmed has not operated at this location in more than two years.

### COMPLAINT/COMPLIANCE HISTORY

No complaints have been received regarding this facility. No Violation Notices (VN) have been issued regarding this facility.

### PROCESS EQUIPMENT AND CONTROLS

Next Tool LLC operates a tool and die shop which shapes metal into customer specific parts. The facility operates multiple machine presses. No painting occurs at this location.

### INSPECTION NARRATIVE

I arrived at the facility and met with Mr. Nicholas Baise. Mr. Baise explained that Next Tool LLC moved into this location within the past two year. The building was empty when Next Tool moved into this location. During the inspection, employees were using the different machine presses to create metal parts.

### APPLICABLE RULES/PERMIT CONDITIONS

This address currently has a permit for T2000 sterilizer autoclave. Permit 144-12 was issued on September 21, 2012. This equipment was not present during the onsite inspection, and had been removed before Next Tool began operations at this location.

The metal die operations performed by Next Tool, LLC are exempt from permitting by Rule 285 (I). The metal shaping equipment all vent inside the plant.
