## Inspection Narrative

I visited the facility location that was previously registered to General Motors Photographic (GMP) in the Wayne County, Michigan to conduct a scheduled compliance inspection. The facility address was located at 31752 Enterprise Drive, Livonia. The purpose of visit to the site was to ascertain compliance with emission limits conditions regulating the incineration process owned and operated by GMP, Inc. Pre-inspection search indicated GMP had set and operated an incinerator at the site under Wayne County Permits C-7587, C-7588 and C-7195 since 1987. I arrived at the site at 1425 hours via Merriman Road, southbound. I turned right onto the Enterprise Drive westbound. The building site looked vacant. The 31752 Enterprise Drive address that housed the catalytic incinerator was no longer at the site. There was no GMP sign on any other building or grounds of the Lot. The vacant space had been developed into a parking Lot and used by a medical consulting business situated adjacently eastward. I drove further westward to the neighboring properties such as the Fresh Dairy and verified that the property was not annexed to GMP. The medical facility adjacent to the Lot was closed at the time of visit so I did not conduct interviews for qualitative verification. I left the Enterprise Drive location at 1525 hours.

## Determination

A visit was made to the site location formerly occupied by General Motors Photographic facility in Livonia, MI for a scheduled compliance inspection. The inspection indicated that GMP no longer operated a catalytic incinerator at the site. There were no emissions from the site. GMP was determined to be in compliance with environmental emission control conditions listed in the Permit to Install documents (C-7587, C-7588, C-7195) issued for operations at the location. The associated Wayne County permits have been recommended for void.
