Building status: About April 2016, Brunt Assoc. sold (\$72 per sq. ft. and 23,000 sq. ft. area with heated floors, \$1,656,000.00) the building to RAMPF Group, Inc. (U-63-15-01805). Brunt moved out about May 23, 2016. Brunt Associates continues to stay in business as a contractor, but Brunt outsourced manufacturing.

VN: AQD issued Violation Notice dated December 22, 2014, for failure to operate the coating booth (paint, stain, varnish, lacquer etc.) properly as designed and intended.

On December 5, 2017, I conducted a level 2 self-initiated **FY 2018 inspection** of Brunt Associates Carpentry and Millwork ("Brunt") located at 48953 Wixom Tech Dr., Wixom, Michigan 48393-3558. The inspection was conducted to determine compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451; and Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) administrative rules.

Mr. George Sollner (Phone: 248-560-0562-Direct or 248-295-0223-ext. 171601; Fax: 248-560-0562; Cell: 248-420-4962; E-mail: George.Sollner@rampf-group.com), VP – Director of Sales, will be retiring soon.

Mr. Brian J. Brunt (Phone: 248-295-4610 – Direct; Cell: NA; Fax: 248-960-8296; E-mail: Brian@BruntAssociates.com), Owner and President, sold the building to RAMPF Group, Inc. (U-63-15-01805). In addition, he sold all machines, equipment, cold-cleaner, paint spray booth, etc. to various buyers.

Brunt Associates is in woodworking business: Architectural & Cabinet Woodwork, Carpentry Contractors, Millwork, etc. Most business dealings are with institutions such as universities, churches, schools, hospitals, etc. Brunt continues to be in business with needed manufacturing outsourced.

Building Sold

About April 2016, Brunt Assoc. sold (\$72 per sq. ft. and 23,000 sq. ft. area with heated floors, \$1,656,000.00) the building to RAMPF Group, Inc. (U-63-15-01805), 49037 Wixom Tech Dr. Wixom, Michigan 48393-3558.

Brunt sold and removed Rule 287(2)(c) Paint Spray Booth. Also, Brunt sold and removed all (≈11) wood cutting, sanding, milling, sanding machines and the associated one common baghouse (Murphy Rogers dust collector).

I conducted an inspection of the building. RAMPF uses the building for materials storage. Polyurethane and epoxy tools and boards are imported from Germany and stored in this building. The materials are supplied to customers in NAFTA trade zone countries. Hardly any transfer of materials take place between the two buildings: 48953 Wixom Tech Dr. (P0577) and 49037 Wixom Tech Dr. (U-63-15-01805); nearby but not adjacent.

Conclusion

The building is sold to RAMPF Group(U-63-15-01805), and all process equipment were removed about May 2016. Brunt Assoc. is still in business but ceased fabrication operations via outsourcing all manufacturing.
