On August 19, 2021, I, Joseph Forth, Michigan Department of Environment, Great Lakes-Air Quality Division (EGLE-AQD) Staff, conducted a scheduled inspection at Dick Huvaere Auto Body Repair Shop located at 66629 Gratiot Ave, Richmond, MI. The purpose of the inspection was to determine the facility's compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control of Natural Resources and Environmental Protection Act, 1994 Public Act 451, as amended, EGLE-AQD Air Pollution Rules, and Permit to Install (PTI) No. 22-15.

I arrived at the location and met with Ms. Janet Delewski, Manager. I introduced myself, stated the purpose for inspection, and provided my credentials. Ms. Delewski then showed me the shop and the coating booths. The shop is mostly space to perform auto body work, no cold cleaners, boilers or back up generators. The facility is permitted for two paint spray booths. During the inspection, one of the booths were in use, the booths appeared to be properly equipped with dry filters. The facility has a recordkeeping requirement for HAPs, I requested these documents be provided electronically.

Compliance

FGFACILITY

I.1 An individual HAP emission limit of less than 9.0 tons per year. Facility has not been tracking their HAP emissions. According to MAERS the facility emitted 1311.06 lbs of VOCs during the calendar year for 2020. If all the VOC were a single HAP the facility would still be under this emission limit. Due to this fact, a violation will not be issued for this condition.

1.2 An aggregate HAP emission limit of less than 22.5 tons per year. Facility has not been tracking their HAP emissions. As stated above, the facility's total VOC emissions for 2020 were less than 1 ton. If all the facility's VOC emissions were HAPs they would still be within this limit. Due to this fact, a violation notice will not be issued for this condition. V.1 AQD has not yet requested verification of HAP content data for the materials used at the facility.

V.1 The permittee shall complete all required calculations in a format acceptable to the AQD District Supervisor by the 15th day of the calendar month, for the previous calendar month, unless otherwise specified in any monitoring/recordkeeping special condition.

VI.1-2 The permittee was not keeping all necessary records. The permittee was unaware of the HAP emission limits and records required by their permit. I referred the permittee to the State of Michigan Environmental Assistance Center for assistance in developing these records. A violation will be issued for failure to keep these records.

Conclusion

The permittee was not tracking, nor keeping records, of the HAP emissions at the facility. A violation will be issued for PTI No. 22-15 Special Conditions VI.1 and VI.2.
