Dear Ms. Weems:

In response to EGLE's AQD Violation Notice dated June 5, 2019 concerning our crushing operations at 2500 E Ganson St. Jackson, Michigan, we have the following responses:

Prior to mobilization on site and crushing on site, both the hiring prime contractor, Crandell Trucking ("Crandell"), and the property owner, Smalley Construction Inc. ("Smalley") informed Dynamic Crushing that the materials to be crushed did not contain any hazardous material.

We are not aware of having crushed any concrete blocks with asphaltic coating on it. The samples taken were from areas of raw material which we had not touched or processed. Upon receiving notification from Craig Dechy on May 21, 2019, we ceased crushing operations at this site and completed our demobilization from this site on May 23, 2019.

In specific response to your request that answers be provided to certain questions, we state the following:

Dates the violation occurred.

We do not believe a violation occurred. Both Crandell and Smalley informed us that the materials to be crushed did not contain any hazardous material, and the samples taken were from areas of raw material which we had not touched or processed.

Explanation of the causes and duration of the violation.

As stated above, we do not believe a violation occurred. Both Crandell and Smalley informed us that the materials to be crushed did not contain any hazardous material, and the samples taken were from areas of raw material which we had not touched or processed. We periodically crushed on this location from 4/15/19 thru 5/21/19, with the material selection/loading beginning on the south end of the site and progressing to the north end where the samples were taken. We terminated crushing operations on the site on 5/21/19 upon receiving notification from EGLE of an alleged violation.
