On September 02, 2016, I conducted a level-2 self-initiated inspection of Adept Plastic Finishing, Inc. ("Adept"), a decorative chromium plastic parts coating facility subject to Area Chrome MACT, located at 48668 Alpha Drive, Wixom, Michigan 48393-3445. The inspection was conducted to determine compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451; Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) administrative rules and PTI No. 121-16.

Neither Mr. Chuck Gibson (Phone: 248-863-5930-ext. 206; Fax: 248-374-5878; E-mail: cGibson@AdeptFinish.com), Plant Manager, nor Mr. Ed Barriager (Phone: 248-863-5930-ext. 206; Fax: 248-960-6120; E-mail: eBarriager@AdeptFinish.com), Waste Water Treatment Manager, was present. Both work at Adept's other chrome facility (N7809) and they left for home early for Friday.

Based upon my observations and conversations with construction workers, the construction of building is completed except landscaping, driveway and parking lot asphalt paving, etc. The chrome plating tanks are not installed yet.
