VIOLATION NOTICE

On January 24, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Marcellus Metalcasters, Inc (Facility), located at 214 East Read Street, Marcellus, Michigan. The purpose of this inspection was to determine the Facility's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); and the Air Pollution Control Rules.

During the inspection, staff of the AQD observed the following:

This process is also subject to the federal Nation Emission Standards for Hazardous Air Pollutants for Iron and Steel Foundries. These standards are found in 40 Code of Federal Regulations, Part 63, Subpart ZZZZZ.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by February 22, 2017 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If the Facility believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
