SECOND VIOLATION NOTICE

On November 15, 2017, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Pro M Restoration Specialists, located at 7170 Big Sky Drive, Suite 1, Holly, Michigan. The purpose of the inspection was to determine Pro M Restoration's compliance with the requirements of the federal Clean Air Act; and Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules.

On March 16, 2017, the AQD sent the company a Violation Notice citing a violation discovered as a result of the inspection and requested your written response by April 6, 2017. A copy of that letter is enclosed for your reference. The response indicated Pro M Restoration would commence installation of the spray booth and exhaust system in a timely manner once the mechanical and electrical permits were submitted and approved by Groveland Township. In addition, a Permit to Install application was to be submitted to the MDEQ for the surface coating equipment. As of this date, surface coating application has continued but no action regarding the response has commenced.

Please be advised that failure to respond in writing and identifying actions the company will take or has taken to resolve the cited violation may result in escalated enforcement action by the AQD. Please provide the information requested in our March 16, 2017 letter by January 5, 2018, which corresponds to 14 days from the date of this letter.

Be further advised that issuance of this Violation Notice does not preclude or limit the DEQ's ability to initiate any other enforcement action under state or federal law as appropriate.
