## VIOLATION NOTICE

On March 12, 2024, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of EPSI located at 1125 Morren Court, Wayland, Michigan. The purpose of this inspection was to determine EPSI compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the Air Pollution Control Rules; and the conditions of Permit to Install (PTI) number PTI No. 16-18B.

During the inspection, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
EUBURNOFF	Special Condition III.5	The facility was required to submit a malfunction abatement plan (MAP) within 90 days of permit issuance. This date appears to have been April 3, 2024. The facility has not submitted the MAP as required.
EUDIPCOAT	Special Condition VI.4	EPSI is required to perform and maintain records of visible emission observations of EU-DIPCOAT at least once per day while the unit is operating. During the most recent inspection the facility indicated that the visible emissions are being done but did not have records to show as documentation as required.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by October 21, 2024 (which coincides with 21 calendar

days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If EPSI believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
