VIOLATION NOTICE

On November 25, 2024, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted a records review of Meg's Hauling LLC located at 67401 Brian Drive, Ray Township, Michigan.

During the review, staff observed the following violation:

EU-PROCESS	PTI 59-23, General Condition 1 R 336.1201	Meg's Hauling LLC has modified the process equipment by installing unpermitted equipment.

During this record review, it was noted that Meg's Hauling LLC had installed and commenced operation of unpermitted equipment at this facility. The AQD staff advised Meg's Hauling LLC on November 25, 2024, that this is a violation of Rule 201 of the administrative rules promulgated under Act 451. Please note that the additional visible emission tests may be required for the unpermitted equipment.

A program for compliance may include a completed PTI application for the concrete crushing process equipment. An application form is available by request, or at the following website: www.michigan.gov/air.

Be advised that Rule 201 requires that a permit be obtained prior to installation, construction, operation, reconstruction, relocation, or alteration of any process or process equipment which may be a source of an air contaminant.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by December 18, 2024 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
