## **VIOLATION NOTICE**

On May 3, 2019, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division, performed an asbestos NESHAP (National Emission Standard for Hazardous Air Pollutants) complaint investigation at 1225 Pipestone Road, Benton Harbor, Berrien County. The purpose of this investigation was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

According to my investigation, La Perla Produce and Mexican Market, owns the subject facility and Deerpath Excavating, Inc., performed the demolition activities. The National Emission Standard for Asbestos holds both the owner and operator equally liable for any violations.

During the inspection, staff observed the following:

Demolition activities had taken place at the former commercial facility with only the concrete slab of the building left to remove. Neither the owner or operator had a thorough asbestos inspection performed prior to the demolition activities and no Notification of Intent to Renovate/Demolish had been submitted to the administrator.

Please initiate actions necessary to correct the cited violations and submit a written response to this violation notice by June 3, 2019, (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations, and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
