Inspection Summary

I entered the store and the desk clerk paged Roy for me who arrived shortly thereafter. I informed Roy of the purpose of my visit and provided him with a copy of my business card and the inspection brochure. According

to Roy, this store has been remodeled approx. three times since becoming VG's Grocery many years ago. The store changed hands from Toms to VG's and is now owned by Spartan Corporate yet the VG's name was retained.

Roy and I walked the building and could not find evidence of an incinerator. There was not a stack visible from the exterior. I feel comfortable stating this device has been removed and the permit is no longer valid.

Roy provided me with a contact for voiding the permit as Eric. On 6/24/16, I attempted to contact Eric by phone for a address to send the void letter. A message was left and this report will be held until further information is provided.

As of 6/27/16, I did not receive a response from Eric; thus the void letter will be addressed to the store and manager.
