Inspection Summary

I entered the store and the desk clerk directed me to Chris. I informed Chris of the purpose of my visit and provided him with a copy of my business card and the inspection brochure. Chris stated that the incinerator

was at the back of the store and was in poor condition. He had me drive around to the backside of the building to where the incinerator was located.

Although the incinerator was still standing, it is in deplorable condition. The electrical hookup and natural gas hookup have since been disconnected and there were numerous holes rusted through the device. I feel comfortable stating this device is no longer useable of operational thus voiding the permit is acceptable.

Chris provided me with the owning business name as Treasure Enterprises to whom I contacted on 6/24/16. I spoke with Vanessa Pringle whom stated that voiding the permit would be in the best interest and there were no plans to utilize the incinerator. This report will be used to void permit 61-721 in accordance with MDEQ memo Procedure for Voiding Permits to Install, dated June 7, 1999.

The following language will be included in the letter since the device is not entirely removed:

This permit is void based on the condition that although the incinerator is still installed, it is inoperable and no longer in use. Please be aware that future use of this device will require further permitting and trigger compliance requirements with one or more of the following federal regulations:

6. Title 40 Code of Federal Regulations Part 60, Subpart FFFF—Emission Guidelines And Compliance Times For Other Solid Waste Incineration Units That Commenced Construction On Or Before December 9, 2004
