SECOND VIOLATION NOTICE

On December 20, 2020, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of the former Crank's Banquet Center located at 27900 Hoover, Warren, MI. The purpose of this inspection was to determine the Hoover Storage Center LLC's and HMC LLC's compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

On January 27, 2021, the AQD sent a Violation Notice citing a violation discovered as a result of the inspection and requested your written response by February 17, 2021. A copy of that letter is enclosed for your reference. As of this date, we have not received your response.

Please be advised that failure to respond in writing and identifying actions Hoover Storage, LLC and HMC LLC will take or has taken to resolve the cited violation may result in escalated enforcement action by the AQD. Please provide the information requested in our January 27, 2021 letter by June 4, 2021, which corresponds to 14 days from the date of this letter.


