**VIOLATION NOTICE**

On May 3, 2021, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of the commercial buildings located at located at 7015 and 7051 N. Monroe, Monroe, MI. The purpose of this inspection was to determine Mr. Bilal Saad’s and Bush Contracting, Inc’s compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Mr. Bilal Saad owns the facilities and Bush Contracting, Inc. performed the demolition activities at the facilities. The NESHAP for Asbestos holds both the owner and operator equally liable for violations.

On May 3, 2021, it was noted that the buildings had been demolished without the required submittal of a 10-day notice of intent to renovate/demolish. Upon review of the asbestos survey for 7015 N. Monroe, the basement was noted as inaccessible and was not surveyed for asbestos prior to demolition.


Please initiate actions necessary to correct the cited violations and submit a signed written response to this Violation Notice by June 11, 2021 (which coincides with 21 calendar days from the date of this letter). The response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Bush Contracting, Inc. or Mr. Bilal Saad believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide factual information to explain your position.
