**VIOLATION NOTICE**

On June 7, 2017 the Department of Environmental Quality (DEQ), Air Quality Division, conducted an inspection of a commercial property located at 3300 Eight Mile Road, Detroit. The purpose of this inspection was to determine House of Dank's, SJ Design & Construction's, and Angelina Construction's compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Mr. Marvin Jamo owns the facility, SJ Design sub-contracted and Angelina Construction performed the demolition activities at the facility. The National Emission Standard for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, staff observed that the building had been demolished without submittal of a 10 day notification of intent to renovate/demolish.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by July 5, 2017 (which coincides with 21 calendar days from the date of this letter). The written response should include:

- Submit a copy of the Notification of Intent to Renovate/Demolish for activities associated with the referenced violation;
- The dates the violation(s) occurred;
- An explanation of the causes and duration of the violations(s);
- Whether the violation(s) are ongoing;
- A summary of the actions that have been taken and are proposed to be taken to correct the violation(s) and the dates by which these actions will take place; and
- What steps are being taken to prevent a reoccurrence.

If House of Dank LLC, SJ Design & Construction LLC, and Angelina Construction LLC believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
