## **VIOLATION NOTICE**

On December 4, 2017, the Department of Environmental Quality (DEQ), Air Quality Division, conducted a complaint investigation of the residential property located at 30 Florence St., Clawson. The purpose of this inspection was to determine Bedient Construction Inc's and Ms. Hanes's compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Ms. Hanes owns the property and Bedient Construction, Inc. performed demolition activities. The National Emission Standard for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, staff observed that 30 Florence St. was demolished without a thorough inspection for asbestos or submittal of the required 10-day notice of intent to renovate/demolish to the DEQ.

Please be advised that because a thorough inspection for asbestos was not conducted by a certified asbestos inspector prior to the initiation of demolition activities, one or more of the following violations may have also occurred:

	§61.150(c)	No signs during loading and unloading

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by February 7, 2018 (which coincides with 21 calendar days from the date of this letter). **Please note that all parties are required to respond to this violation notice.** The written response should include:

- The dates the violations occurred;
- An explanation of the causes and duration of the violations;
- Whether the violations are ongoing;
- A summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and
- What steps are being taken to prevent a reoccurrence.

If Bedient Construction, Inc. and/or Ms. Hanes believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
