SECOND VIOLATION NOTICE

On May 3, 2018, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of commercial building located at 19151 Plymouth Road, Detroit, Michigan. The purpose of the inspection was to determine Blue Lake Property Management, LLC's and JB Contractors, Inc.'s compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

On May 22, 2018, the AQD sent Blue Lake Property Management, LLC and JB Contractors, Inc. a Violation Notice citing violations discovered as a result of the inspection and requested your written response by June 12, 2018. A copy of that letter is enclosed for your reference. As of this date, we have not received your response.

Please be advised that failure to respond in writing and identifying actions JB Contractors, Inc. will take or has taken to resolve the cited violations may result in escalated enforcement action by the AQD. Please provide the information requested in our May 22, 2018 letter by July 10, 2018, which corresponds to fourteen days from the date of this letter.

Please submit the written response to Ms. Tammy Bell, Senior Environmental Quality Analyst at the DEQ, AQD, 3058 West Grand Boulevard, Suite 2-300, Detroit, Michigan 48202 and submit a copy to Ms. Jenine Camilleri, Enforcement Unit Supervisor at the DEQ, AQD, P.O. Box 30260, Lansing, Michigan 48909-7760.

Be further advised that issuance of this Violation Notice does not preclude or limit the DEQ's ability to initiate any other enforcement action under state or federal law as appropriate.


