Dear Mr. Ragalyi:

This letter is in reference to your Permit to Install (PTI) application, identified as No. 13-19B, for proposed changes to a previously permitted project involving a new automotive paint shop and changes to the existing automotive assembly line at the Warren Truck Assembly Plant located at 21500 Mound Road in Warren, Michigan (State Registration Number B2767).

The public comment period ended on June 14, 2021, and a public hearing was held on June 2, 2021. Comments were received during the comment period and at the public hearing. After careful consideration of the issues and pursuant to the delegation of authority from the Director of the Michigan Department of Environment, Great Lakes, and Energy (EGLE), I have approved PTI No. 13-19B with no modifications made to the proposed permit.

The Air Quality Division (AQD) has prepared the enclosed Response to Comments (RTC) Document, which provides our responses to comments received during the public comment period and at the public hearing.

This approval is based upon and subject to compliance with all administrative rules of EGLE and conditions stipulated in the enclosed supplement. Please review these conditions thoroughly so that you may take the actions necessary to ensure compliance with all of these conditions.

The equipment covered by this permit is also subject to the requirements of the Renewable Operating Permit Program. Submittal of the M-001 and C-001 forms may be required prior to commencing operation. A change that is subject to Rule 215 subrules (1), (2), or (3), promulgated pursuant to Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, requires the submittal of the forms to the appropriate AQD District Office. If a change is made pursuant to Rule 216, please submit the required forms to the Cadillac District Office at the address provided in the M-001 form instructions. Also, you must notify the Warren District Office, in writing, within 30 days after completion of the installation, construction, reconstruction, relocation, or modification of the process or process equipment covered by this PTI.
