Dear Interested Party:

You are receiving this letter because you have indicated an interest in actions associated with FCA US LLC (FCA). This letter is to update you on a Permit to Install (PTI) application for FCA. PTI Application No. 13-19B proposed changes to a previously permitted project involving a new automotive paint shop. It also included proposed changes to the existing automotive assembly line at the Warren Truck Assembly Plant (Warren Truck). Construction of the project is underway, as allowed under PTI No. 13-19A. Proposed changes to the project include the number and size of various fuel burning equipment, including a new boiler; updates to existing emission and fuel usage limits; changes to the location of pollution control equipment; and updates to exhaust stacks.

The law requires the Michigan Department of Environment, Great Lakes, and Energy (EGLE) to allow the public to comment on some actions, such as the application for FCA. Public comments are a very important part of making sure the application has been thoroughly reviewed.

If a public hearing is requested in writing by May 28, 2021, a virtual informational session and public hearing will be held on June 2, 2021. The virtual informational session will begin at 6:00 p.m., at which time, staff will be available to answer questions. The virtual public hearing will follow the informational session. The sole purpose of the hearing will be to take formal testimony on the record and staff will be unable to respond to you during this portion. You may contact the Air Quality Division at 517-582-5095 on June 1, 2021, to determine if a hearing was requested and will be held.
