Dear Mr. Brieda:

This letter is in reference to your Permit to Install (PTI) application, identified as No. 14-19A, State Registration Number N2155. The application was received on April 30, 2020, for modifications to the permitted automotive assembly line currently under construction at your existing facility located at 4000 Saint Jean Street, Detroit, Michigan.

Review of your PTI application is complete. We have announced a combined public comment period with PTI Application No. 33-20 for FCA US, LLC, Jefferson North Assembly Plant, as required by state and federal regulations, on the intent of the Michigan Department of Environment, Great Lakes, and Energy (EGLE) to approve the proposed permit. The public comment period will begin on August 5, 2020 and will end on September 18, 2020. A virtual informational session has been scheduled for August 25, 2020. A second virtual informational session and public hearing have been scheduled on September 9, 2020. You may submit comments during the comment period and are encouraged to appear at the virtual informational sessions and public hearing on behalf of your PTI application.

After resolving any issues raised during the public comment period and hearing, a final decision will be made on your PTI application.

By law, construction of the proposed process should not begin until you receive an approved PTI. *This letter is not an approved permit to install* and only references a proposed action on your PTI application.

Enclosed are copies of the proposed permit conditions, "Notice of Air Pollution Comment Period and Public Hearing," "Proposed Project Summary," and the "Technical Fact Sheet" regarding our analysis of your proposed project.
