Dear Interested Party:

You are receiving this letter because you have indicated an interest in actions associated with a company in the area where Ajax Materials Corporation is proposing to locate. This letter is to update you on a Permit to Install (PTI) application for Ajax Materials Corporation. PTI Application No. APP-2021-0019 is for the proposed installation and operation of a new hot mix asphalt (HMA) plant. The HMA plant is proposed to be located at 5088 Energy Drive in Flint, Michigan.

The law requires the Michigan Department of Environment, Great Lakes, and Energy (EGLE) to allow the public to comment on some actions, such as the application for Ajax Materials Corporation. Public comments are a very important part of making sure the application has been thoroughly reviewed.
