Dear Keith Strickland:

This letter is in reference to your Permit to Install (PTI) application, identified as No. APP-2022-0125, for changes to your existing automotive manufacturing process located at 4000 St. Jean Street in Detroit, Michigan (State Registration Number N2155).

The public comment period ended on September 9, 2024, and a public hearing was held on September 5, 2024. Comments were received during the comment period and at the hybrid public hearing. After careful consideration of the issues and pursuant to the delegation of authority from the Director of the Michigan Department of Environment, Great Lakes, and Energy (EGLE), I have approved PTI No. 14-19B with modifications made to the proposed permit.

The Air Quality Division (AQD) has prepared the enclosed Response to Comments (RTC) Document, which provides our responses to comments received during the public comment period and at the public hearing. It also identifies the special conditions that have been modified and provides our rationale for modifying the proposed special conditions. These changes are listed in Section II of the RTC Document. The RTC Document and the Permit Terms and Conditions are available at Michigan.gov/EGLEAirPublicNotice, choose “[Final Decisions](#).”

This approval is based upon and subject to compliance with all administrative rules of EGLE and conditions stipulated in the enclosed supplement. Please review these conditions thoroughly so that you may take the actions necessary to ensure compliance with all of these conditions.

The equipment covered by this permit is also subject to the requirements of the Renewable Operating Permit (ROP) Program. Submittal of the M-001 and C-001 forms may be required prior to commencing operation. A change that is subject to Rule 215 subrules (1), (2), or (3), promulgated pursuant to Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, requires the submittal of the forms to the appropriate AQD District Office. If a change is made pursuant to Rule 216, please submit the required forms to the Grand Rapids District Office at the address provided in the M-001 form instructions.

Additional information is included in the M-001 form instructions which are available on the Internet or can be obtained by contacting the Detroit District Office at 313-456-4681. The AQD ROP Web page is located at [Renewable Operating Permits \(ROPs\) / Title V](#).

Also, PTI No. 14-19A will be voided because the equipment is now covered by PTI No. 14-19B.
