We wanted to let you know about the rescheduled informational session and public hearing for Air Permit to Install (PTI) Application No. APP-2022-0125 for FCA US LLC – Detroit Assembly Complex – Mack located at 4000 Saint Jean Street in Detroit, Michigan.

The application is to modify their current <u>Permit to Install 14-19A</u> for the existing automotive assembly plant by adding requirements for the continued operation of a second regenerative thermal oxidizer (RTO2) and increasing particulate matter emission limits. The public comment period opened on June 12 and will end on September 9, 2024. Comments may be given at any time before the end of the comment period.
