Dear Interested Party:

Thank you for your interest in Permit to Install (PTI) Application No. APP-2022-0192 submitted to the Michigan Department of Environment, Great Lakes, and Energy (EGLE) by the Warren Waste Water Treatment Plant. The Application was a request to install a new sewage sludge disposal process at 32360 Warkop Avenue in Warren, Michigan.

Pursuant to state and federal requirements, the Air Quality Division (AQD) held a public comment period that ended on August 20, 2024, with a virtual public hearing on August 8, 2024, on the proposed conditional approval of the permit. We received two written comments and three voicemail comments during the public comment period.

After careful consideration of the issues and pursuant to the delegation of authority from the Director of EGLE, I have approved PTI No. 112-24 with modifications made to the proposed permit.

The Response to Comments (RTC) Document provides our responses to comments received during the public comment period and at the public hearing. It identifies special conditions that have been modified and provides our rationale for making those modifications. The changes are listed in Section II of the RTC. The RTC and the Permit Terms and Conditions are available at: Michigan.gov/EGLEAirPublicNotice, choose "Final Decisions."

Changes made to the permit include:

- Several permit conditions were revised to replace "satisfactory manner" with alternate language and one condition was revised to remove the word "satisfactory".
- The first FGBIOCONERS testing condition was revised to remove an extra "after" in the first sentence.
