Dear Interested Party:

We are sending you this information because you may have an interest in air quality related activities associated with the Warren Waste Water Treatment Plant (Warren WWTP). The company has submitted an air permit application (No. APP-2022-0192) for the proposed installation and operation of a new sewage sludge disposal process. The new sewage sludge disposal process is proposed to be located at 32360 Warkop Avenue in Warren, Michigan.

The law requires the Michigan Department of Environment, Great Lakes, and Energy (EGLE) to open some actions for the public to comment on, such as what Warren WWTP is requesting. Public comments are a very important part of making sure the application has been thoroughly reviewed.

Information about the air permit application, such as a summary of the proposed project, the proposed permit conditions, and the fact sheet containing the regulatory analysis of the proposed permit conditions are available to review.
