

NOTICE of AIR PERMIT COMMENT PERIOD and PUBLIC HEARING

The Michigan Department of Environment, Great Lakes, and Energy (EGLE) is holding a public comment period and a virtual public hearing to allow the public the opportunity to comment on the proposed conditional approval of an air permit.

There is a public comment period from October 10, 2024 until November 26, 2024, and a virtual public hearing on November 19, 2024 for:

Company: Smiths Creek Landfill located at 6779 Smiths Creek Road, Smiths Creek, Michigan

What the company wants to do: Application No. APP-2024-0005 is a request to permit and operate an existing open flare with a proposed vacuum adsorption vessel for odor control.



Technical details:

The public comment period and virtual public hearing are to allow all interested parties an opportunity to comment on the proposed conditional approval of an air permit also called a Permit to Install.

It has been preliminarily determined that the open flare will not violate EGLE's rules nor the National Ambient Air Quality Standards. The facility's impact will not exceed the available increments for sulfur dioxide, nitrogen oxides, particulate matter less than or equal to ten microns in diameter, and particulate matter less than or equal to 2.5 microns in diameter.
