Dear Hasan Yamani:

This letter is in reference to your Permit to Install (PTI) application, identified as No. APP-2024-0037, for installation of a food safety manufacturing facility located at 720 East Shiawassee Street in Lansing, Michigan (State Registration Number P1446).

The public comment period ended on October 18, 2024. No comments were received nor was a request for a public hearing made during this period. Pursuant to the delegation of authority from the Director of the Michigan Department of Environment, Great Lakes, and Energy (EGLE), I have approved PTI No. 120-24.

During the public comment period, a typographical error and two administrative errors were found. Also, two clarifying items were added to the permit.

- The typographical error was found in Special Condition (SC) V.1 for FGNESHAPO of the proposed conditions. The error stated the permittee "much" and it was changed to the permittee "must."
- One administrative error was in SC VI.6(a) for FGNESHAPO. This condition is for facilities that use less than 100 lb/year of ethylene oxide (EtO), and the facility will be using more than 100 lb/year of EtO. Therefore, that condition is not applicable to the facility and was removed from the permit.
- The other administrative error was omitting R 336.1940 as an underlying applicable requirement (UAR) to the special conditions. This UAR was added to all the conditions within FGNESHAPO.
- One clarifying item added to the permit was including the U.S. Environmental Protection Agency's (USEPA) group 1 air emissions and group 2 air emissions in the definition of FGNESHAPO.
- The other clarifying item was including "A device to measure the facial velocity air through all natural draft openings in the enclosure" and "A device to measure the pressure drop across the enclosure" to SC IV.5(b) and (c), SC IV.6(b) and (c), and SC IV.7(b) and (c) in FGCOATING.

This approval is based upon and subject to compliance with all administrative rules of EGLE and conditions stipulated in the enclosed supplement. Please review these conditions thoroughly so that you may take the actions necessary to ensure compliance with all these conditions.
