Subject: Response to Second Violation Notice Dated November 19, 2022 MI-ROP-B2876-2019a Michigan Sugar Company – Croswell Factory

Dear Ms. Wells,

Michigan Sugar Company (MSC) respectfully submits this response to the November 16, 2022 Second Violation Notice (SVN) issued by the Michigan Department of Environment, Great Lakes and Energy (EGLE). In the SVN, EGLE states that the previous written response to VN20220919, (received by EGLE on October 10, 2022) failed to demonstrate that adequate CEMS operation and quality assurance/quality control are being implemented, including operating, recordkeeping, and oversight for the CEMS unit in Croswell.

EGLE has requested we review the regulations and situation regarding the Riley Boiler operation on April 1, 2022:

The Croswell Riley Boiler was operated for 10 hours on April 1, and then shuttered for the intercampaign period lasting until August, 2022. The seasonal facility operation processes sugar beets up to the period they run out of beets or the beet quality diminishes to the point that extractable sugar is no longer viable.

Point #1; The status of the boiler was in Shutdown Mode since the facility was not operating. 40 CFR 60, Appendix A at paragraph 5.1.4 states in part:

Also, cylinder gas audits are not [to] be required for calendar quarters in which the **affected facility** does not operate. We assert the **sugar beet processing facility** was not operational and the Riley boiler was not operating normally, but rather in shutdown mode.

Point #2: A cylinder gas audit or CGA for the Riley Boiler CEMs was conducted 3/2/2022. 40 CFR 60 Appendix F paragraph 5.1 states:

Each CEMS must be audited at lease once each calendar quarter. Successive quarterly audits shall occur **no closer than 2 months**. April 1, 2022 is closer than 2 months to the precious CGA, indicating an audit was not possible before the boiler was shuttered for the inter-campaign period.
