The facility was last inspection on December 5, 2008. The address was previously listed for Multi-Feed, however during the last inspection, the facility personnel stated that Paff had been at this location since at least 1998. A previous report for this facility is listed under the SRN of U82080763.

PROCESS EQUIPMENT AND CONTROLS

The facility was an operating as an electrician's office. The majority of work would occur at the customer's location.

INSPECTION NARRATIVE

I attempted to perform an inspection at this location on Tuesday March 18, 2014 at 11:45 am. I arrived at the facility, which had an identification sign on the door of the facility identifying the building as being Paff Electric. I attempted to open the door, and it was located. The building looked dark inside. There was a note taped to the door directly all deliveries to be left at Concealed Security Systems, which is located next door to the facility. There were service vans in the parking lot, with the Paff Electric logo painted on the side.

The facility maintains a website (<u>www.paffelectric.com</u>). It appears that the services, including electrical contractor for residential, commercial and industrial customers, are performed at the customers' location. The majority of the information on the website seems to have been removed since I initially researched this facility. This facility is not operating under any permits.

On Friday August 22, 2014 I drove past the facility and I saw a for-sale / for-lease sign in front of the building. Based on the lack of information available on the company website and the for-sale sign on the property, I am assuming that the business is no longer operating.
