VIOLATION NOTICE

Based on emission factors from stack tests performed on May 25th, 26th, 31st and June 1st and 2nd, 2016, Dow AgroSciences, LLC, located at 350 North Huron Avenue, Harbor Beach, Michigan, is not in compliance with special condition FG-TURBINES, I.2 of Renewable Operating Permit number MI-ROP-B4942-2015.

On October 28, 2016, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), received emissions records, as requested by email. The purpose of the request was to assist in a review of test results from stack tests

Special condition FG-TURBINES, I.2, limits the emissions of NOx_TEG & Turbine Running Modes to 3.8 lb/hr based upon a calendar day averaging period. Emission factors used for the calculations shall be based on the most recent testing data for each turbine in FG-TURBINES. Using the most recent test emission factors identified several NOx emission exceedances since the date of the test.

During the record review, staff observed the following:

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by November 28, 2016 (which coincides with 21 calendar days from the date of this letter, including holidays). The written response

should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Dow AgroSciences, LLC believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
