A review of the submittal indicated that this submittal was the second time that emissions for the EU were reported. The 2020 submittal also reported using MAERs EF, but the emissions did not correspond with the EFs and the thruput. However, the 2021 submittal EFs and Emissions do correspond appropriately. The NOx and CO EFs used for the compressor engines correspond to the two most recent stack tests (2018 and 2019).
