SECOND VIOLATION NOTICE

On August 8, 2018, the Department of Environmental Quality (DEQ), Air Quality Division (AQD) conducted an inspection of E-Z 49 Minute Cleaners (Company), located at 12415 Morang Avenue in the City of Detroit, Michigan. The purpose of the inspection was to determine the Company's compliance with the requirements of the federal Clean Air Act; and Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

On August 22, 2018, the AQD sent the Company a Violation Notice (VN) citing violations of the federal National Perchloroethylene Air Emissions Standards for Dry Cleaning Facilities, Title 40 of the Code of Federal Regulations, Part 63, Subpart M, the Public Health Code, 1978 PA 368, as amended, and the Dry Cleaning Establishment Rules Utilizing Class I, II, III, and IV Solvents. These violations were discovered because of the inspection and requested the Company's written response by September 12, 2018. A copy of this VN has been enclosed for your reference. As of the date of this letter, the AQD has not received the Company's written response to the cited violations.

Please be advised that failure to respond in writing and identifying actions the Company will take or has taken to resolve the cited violations may result in an escalated enforcement action by the AQD. Please provide the information requested in the VN dated August 22, 2018, by **October 1, 2018**, which corresponds to 14 days from the date of this letter.



VIOLATION NOTICE

On August 8, 2018, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Best Cleaners, 32974 Woodward Avenue, Royal Oak, Michigan. The purpose of this inspection was to determine Best Cleaners' compliance with the requirements of the federal Clean Air Act and Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

Specifically, this dry cleaner is subject to the federal National Perchloroethylene Air Emission Standards for Dry Cleaning Facilities, Title 40 of the Code of Federal Regulations (CFR), Part 63, Subpart M and the Public Health Code, 1978 PA 368, as amended, Dry Cleaning Establishment Rules Utilizing Class I, II, III, and IV Solvents.

During the inspection, staff observed the following:

Commercial, Dry to Dry, Type IV Perchloroethylene dry cleaning facility	40 CFR 63.322(m)	There is a perc vapor leak at the button trap (999ppm) on the North dry cleaning machine.
	40 CFR 63.322(o) (1)	The monthly leak check with a halogenated hydrocarbon detector has not been performed.
	40 CFR 63.323(a) (1)(ii)	The cooling coil temperature on the North dry cleaning machine is not 45°F or less (88°F).
	40 CFR 63.324(d) (1,2,3,4,5)	The NESHAP temperature, leak detection, repair, and perc purchase logs are not being kept for the dry cleaning machines.

Process Description	Rule/Permit Condition Violated	Comments
	R 325.17107(a)	The still sludge and lint waste are not being stored in covered, hazardous waste containers and properly disposed of.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by September 12, 2018 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a recurrence.

If E-Z 49 Minute Cleaners believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
