VIOLATION NOTICE

On July 31, 2014, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted a site visit of Holland Hospital located at 602 Michigan Avenue, Holland, Michigan. The purpose of this site visit was to determine Holland Hospital's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); and the administrative rules.

During the site visit, staff observed the following:

Process Description	Rule/Permit Condition Violated	Comments
Dual Fuel Boiler	Rule 336.1201	Failure to obtain a Permit to Install.

During this site visit, it was noted that Holland Hospital had installed an unpermitted boiler at this facility. The AQD staff advised Holland Hospital on July 31, 2014, that this is a violation of Act 451, Rule 201.

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by August 25, 2014 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Holland Hospital believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
