On Thursday, July 11, 2019, a scheduled site inspection was conducted by AQD District staff at Zubek Motor Facilities in Oscoda, losco County, Zubek representative Mr. Terry Edmonds, Service Manager, answered questions and provided a tour of the facility. Site inspection activities were conducted with the intent of confirming compliance with Michigan's Air Pollution Control Rules.

## **FACILITY DESCRIPTION & HISTORY**

Located at the northwest corner of the intersection of State Street (M-23) and Cedar Lake Road, the facility is presently an auto dealership and service location. The business is in the downtown area, which is comprised of commercial and residential properties. No complaints are of record for the facility

The facility was previously permitted under Permit to Install (PTI) No. 251-85 for two Lanair waste oil furnaces with a maximum output of 250,000 Btu/Hr. As of the most recent inspection conducted on May 7, 2009, only one waste oil furnace was present at the site - the Lanair MX300 rated at approximately 300,000 Btu/hr. It was determined the furnace may be exempt from permitting pursuant to R 336.1282(2)(b)(iv), because the waste oil used in the furnace is generated onsite and the heat input capacity is less than 500,000 Btu/hr. The PTI was voided on June 22, 2009.

## **COMPLIANCE EVALUATION**

The Lanair MX300 was still onsite at the time of the inspection, and Mr. Edmonds reported no changes had occurred with the unit since 2009. Waste oil generated by the service center is used to fire the unit. Mr. Edmonds indicated there were no other heaters, furnaces, or boilers onsite, and no painting activities occur at this location. The furnace is used in cooler weather and was not operating at the time of the inspection.

In a follow-up call with Mr. John Zubek, owner, on Monday, July 15, he confirmed there are no cold cleaners or vapor degreasers onsite.

## COMPLIANCE DETERMINATION

At this time, Zubek Motor Facilities in Oscoda appears to be in general compliance with all applicable rules and regulations.
