The Detroit database indicates that there is a business associated with SRN M4684 located at 5131 Saint Aubin St., MI 48211.

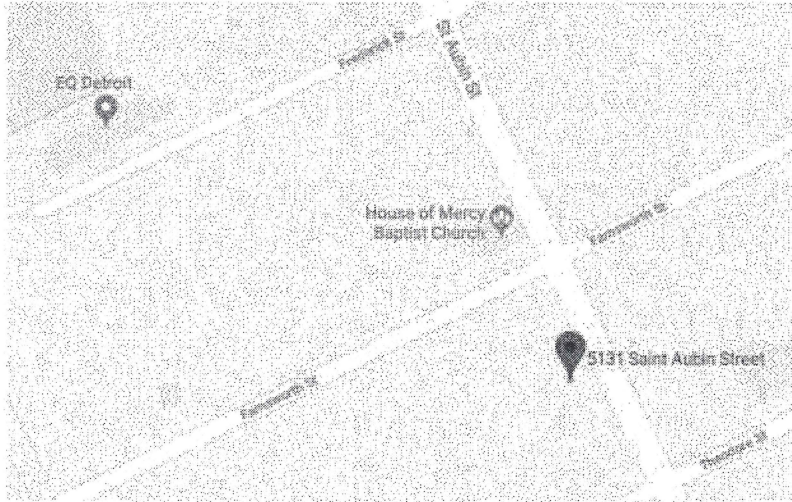
On 9/14/2018 I arrived at the cited location to conduct an inspection of the site. I drove north and south on Saint Aubin St. but I did not find any business with the name Detroit Cabinet; instead, I found a series of vacant lots. The vacant lots occupied the whole area along St. Aubin St. from Farnsworth St. to Theodore St. The former facility seemed to have been located somewhere in that block , between Farnsworth St. and Theodore St.

The specific date of equipment removal and building demolition is unknown. However, a search of Google Earth Satellite Imagery from 1999 to the present suggest the timeframe when the demolition of the former business might have occurred. In 1999 the image shows two buildings located near the SW corner of Farnworth St. and Saint. Aubin St. The imaging transition suggest that one of the building might have been demolished during the period from 7/17/2001 to 3/24/2002 and the second one may have been torn down down sometime after 12/30/2005 and before 8/3/20016. Please refer to the attached map/image for the location and status of the site at the time of the inspection.

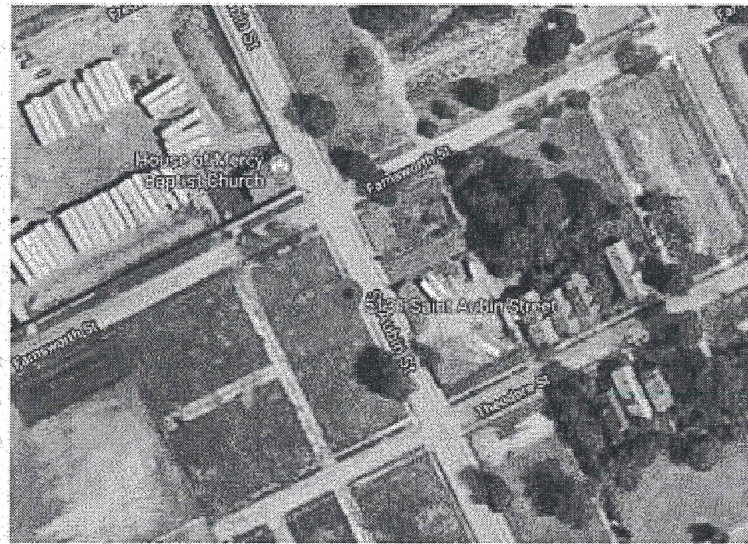
