SECOND VIOLATION NOTICE

On August 4, 2016, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Haviland Enterprises, located at 421 Ann Street NW, 521 Ann Street NW, and 2168 Avastar Parkway, Grand Rapids and Walker, Michigan. The purpose of the inspection was to determine Haviland Enterprises' compliance with the requirements of the federal Clean Air Act; and Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); and the Air Pollution Control Rules.

On September 2, 2016, the AQD sent Haviland Enterprises a Violation Notice citing violations discovered as a result of the inspection and requested your written response by September 23, 2016. A copy of that letter is enclosed for your reference. On September 23, 2016 Haviland Enterprises provided a written response outlining a plan for compliance including dates of completion for several action items with the first item to be completed by October 31, 2016. As of this date, AQD has not received any of the items requested in that Violation Notice.

Please be advised that failure to submit the identified action items outlined in the Violation Notice may result in escalated enforcement action by the AQD. Please provide the information requested in our September 2, 2016 letter by November 29, 2016, which corresponds to 14 days from the date of this letter.

Be further advised that issuance of this Violation Notice does not preclude or limit the DEQ's ability to initiate any other enforcement action under state or federal law as appropriate.
