Re: Comfort Research, Inc. Response to Violation Notice Dated October 29, 2013

Dear Ms. Plafcan:

On November 1, 2013 Comfort Research, Inc. ("Comfort Research") forwarded electronic copies of data identified in the violation notice. This letter supplements Comfort Research's response provided electronically to the MDEQ-AQD Grand Rapids District Office on November 1, 2013.

1. Records of EPS Bead Throughput

The first item discussed in the October 29, 2013 Violation Notice concerns records of EPS bead throughput. EPS raw bead throughput is recorded each day and summarized in spreadsheet form. As described above, a copy of the missing record was forward electronically upon receipt of the VN notification. Please note the daily information is summarized and tabulated on the specific monthly data sheet (for example August, 2013) and a separate data sheet tallies the individual monthly data and is summarized on the sheet labeled; *EPS Processing Emissions Summary*. This sheet was also forwarded on November 1. A copy of both reporting sheets will be forwarded to your office within 30 days of the end of the calendar month, in accordance with the Consent Order requirements.

2. Records of the Pounds of VOC per 100 Pounds of EPS Beads

Each monthly sheet includes the pounds of VOC per 100 pounds of EPS bead. This appears at the top of the monthly summary sheet in the row that is labeled; *Raw Bead Pentane Content*. The value is expressed as a percentage (%) by weight as listed on the MSDS from the supplier. By definition, pentane is a VOC and the unit of percentage by weight recorded from MSDS is equivalent to pounds per 100 pounds. Therefore Comfort Research believes the unit of reporting is accurate to the requirement outlined in the Consent Order at Paragraph 15.

Air permit number 150-12A was based on emissions quantifications from the pentane content tabulated as formulation content of pentane for the EPS bead listed on the supplier data. The emissions are reported based on the assumption that all pentane used to make the raw bead is lost at Comfort Research upon first pass expansion in the Hirsch unit. For several reasons this method of quantifying emissions over states the pentane (and hence VOC emissions) that are tabulated and summarized as monthly emissions. Regardless, the pentane (VOC) content of the bead processed in a given month is reflected on the monthly summary sheets forwarded to the AQD. Additional copies for July, August and September 2013 (Monthly) and the (annual) emissions summary sheets through September are attached to this response. We acknowledge both the monthly sheet and the annual summary sheet must be submitted each month to comply with the Consent Order provisions and copies will be forwarded to the District Supervisor each month in accordance with the CO provisions.

3. 12-Month Rolling Time Period Records

As stated in response #2 above, the individual monthly data is aggregated on to the EPS Processing Emissions Summary Sheet and additional copies are attached to this response. The Processing Emissions Summary sheet includes columns which tabulate the 12-month rolling calculation for both the total mass of EPS bead utilized/processed and the 12-month rolling sum of the VOC emissions assuming 100% of the formulated pentane is lost at the Hirsh unit during the first pass EPS expansion step. We acknowledge both the monthly sheet and the annual summary sheet must be submitted each month to comply with the Consent Order provisions and copies will be forwarded to the District Supervisor each month in accordance with the CO provisions.
