VIOLATION NOTICE

On May 5, 2015, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted a records review of Comfort Research located at 1719 Elizabeth Avenue NW, Grand Rapids, Michigan. The purpose of this review was to determine Comfort Research's compliance with the requirements of the federal Clean Air Act; Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451); the administrative rules; the conditions of Renewable Operating Permit (ROP) number MI-ROP-N1916-2014; and Consent Order AQD number 4-2013.

As part of this review, the following reporting violation was identified:

This is a violation of reporting requirements specified in ROP No. MI-ROP-N1916-2014, FGBEADXPANDER, Special Conditions VII.4.a and VII.4.c which require data collected and recorded be submitted to the AQD District Supervisor within 30 days following the end of the calendar month.

The cited ROP No. MI-ROP-N1916-2014, FGBEADXPANDER, Special Conditions VII.4a and VII.4c are also enforceable as paragraph 11 C of Consent Order AQD number 4-2013 .

Please initiate actions necessary to correct the cited violation and submit a written response to this Violation Notice by May 21, 2015 (which coincides with 14 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Comfort Research believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
