On March 26, 2017 and April 3, 2018, I (Kerry Kelly) conducted an inspection of Allan Roisen (Aircraft Custom Cabinetry) located at 17060 Masonic Boulevard #107, Fraser, Michigan. This facility is identified by the State of Michigan with the State Registration Number (SRN) N2788. The purpose of this inspection was to determine the facility's operating status and compliance with Permit to Install (PTI) number 100-91.

I arrived at 17060 Masonic Boulevard at approximately 2:30 PM on March 26, 2017. 17060 Masonic Boulevard is one of three buildings in "Fraser Industrial Mall". Each building, which has it's own address, contains about five separate suites. There was no sign on the address listed on PTI 100-91 (17060 Masonic Blvd. Suite 107), the door was locked, and the suite appeared to be vacant (attachment 1).


Following the inspection I called the real estate agent on the sign outside the complex to see if Suite 107 was vacant. The agent gave me the contact information for the building manager, Mark, who put me in touch with the current occupant, Mike of Superior Carpentry. Mike stated that suite 107 did not have a paint booth and agreed to show me the interior on April 3, 2018.

On April 3, 2018, I arrived at 17060 Masonic Boulevard Suite 107 at approximately 7:55 AM. I introduced myself, explained the purpose of my visit, and showed my photo credentials to Mike. According to Mike he is rarely in the building and uses it primarily for storage. In the building I did observe one small (<50,000,000 btu/hour) natural gas-fired space heater and several saws. The emissions from the saws were released only into the general in-plant environment. Both the space heater and the saws appear to be exempt from the requirement in R 336.1201 to obtain a permit to install per R 336.1282(2)(b)(i) and R 336.1285(2)(l)(vi) respectively. Also in the building, Mike showed me vents on large doorway that looked like they might have been part of a ventilation system (attachment 2). I inspected the interior and ceiling of the facility and did not see a paint booth or stack.

Based on this inspection, it appears the paint booth permitted in PTI 100-91 has been removed from the 17060 Masonic Boulevard Suite 107. I requested AQD permit staff void PTI 100-91 (attachment 3) as a result.
