For the period from January 2019 through June 2019 company records show there were five instances where records showed flow to the flare with a temperature indicative of no flare operation. In each case, CSL believes that the flare was operational. CSL contracted with APTIM to inspect the control system and conduct system integrity tests. APTIM verified that the gas flow to the flare was shutdown, as designed, when the flare did not have a flame. APTIM also adjusted scaling of the flow meter. The company acknowledges problems with data recording and is continuing to investigate the problem and determine a solution. Since this is an ongoing issue, a violation notice will be sent.
