SRN reassign: Art Moran Pontiac Buick GMC, Inc. (N3928). About 2010, Art Moran consolidated its service and bodyshop operations to one location at 29300 Telegraph (U-63-11-0064) → Southfield Collision Center, Inc. (N3928). About 2011, SCC rented the building from Art Moran and started its collision shop business and soon went out of business. → Amerifleet, Inc. (N3928). Amerifleet is conducting car fleet management service business renting the building from Art Moran.

Voided: Permit-to-Install Nos. 1107-92 dated October 4, 1993 and 1108-92 dated October 18, 1993, were vided on February 23, 2011, based upon FY 2011 inspection.

On May 13, 2016, I conducted a level-2 self-initiated inspection of Amerifleet, Inc. located at 21375 Telegraph Road (Fleet Operation), Southfield, Michigan 48033-4216. The inspection was conducted to determine compliance with the Federal Clean Air Act; Article II, Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451; and Michigan Department of Environmental Quality, Air Quality Division (MDEQ-AQD) administrative rules.

- 1. **N3928**: Art Moran Pontiac Buick GMC, Inc., 21375 Telegraph Road (Body-shop), Southfield, Michigan 48033-4216. Art Moran vacated the building and leased it to Southfield. Art Moran removed three of three booths and other process equipment and moved them to 29300 Telegraph Road (U-63-11-0064) in order to consolidate its operations (only two of three booths were installed at new location). Art Moran is operating its booths (2) at new location pursuant to Rule 336.1287(c) exemption.
- 2. **N3928**: Southfield Collision Center, Inc., 21375 Telegraph Road (Body-shop), Southfield, Michigan 48033-4216. SCC went out of business. Art Moran's SRN N3928 was reassigned to SCC because it was located at the same address. However, SCC moved out or went bankrupt.
- 3. **N3928**: Amerifleet, Inc., 21375 Telegraph Road (Fleet Operations), Southfield, Michigan 48033-4216. Amerifleet is leasing the building from Art Moran. Art Moran's SRN N3928 is reassigned to Amerifleet because it is located at the same address.

4. **U-63-11-0064:** Art Moran Buick GMC, Inc., 29300 Telegraph Road, Southfield, Michigan 48034-1341. Art Moran consolidated both Body-shop and Service-shop at one location after the move from 21375 Telegraph Road to 29300 Telegraph Road.

During the FY 2016 inspection, Mr. Rob Thompson (Phone: 574-302-6102), Over-the-Road Driver, and Mr. Paul Fudold (Phone: 248-799-0095; E-mail: Paul.Fudold@Amerifleet), Fleet Manager, assisted me.

Founded in 1997, Amerifleet is in the business of vehicle logistics service on nation-wide basis. Amerifleet has 75 storage locations in US and Canada.

Amerifleet manages car / sports utility vehicle fleets for automobile manufactures, car rental businesses, corporations, institutions, etc. All repair and painting jobs are outsourced and no painting and repair activity takes place at this site. Hundreds of mostly cars and some sports utility vehicles are stored at the site; some indoors and others outdoors. Security cameras are present. Fleet management (vehicle logistics service) principally involves moving vehicles from one location to other (e.g. Detroit to Chicago or New York).
